**A proposed Settlement has been reached in a class action lawsuit known as Cline v. Inline Network Integration LLC, Case No.: 2023LA000402, ("Lawsuit"), filed in Illinois Circuit Court of the 18th Judicial Circuit, County of DuPage.**

**What is this about?** This Lawsuit arises out of the unauthorized access to Inline Network Integration LLC's ("Inline") systems, which was discovered by Inline on or about March 12, 2022 (the "Data Security Incident"), and allegations concerning certain files allegedly accessed during the Data Security Incident that may have contained Private Information obtained and maintained by Inline. Allegedly, that Private Information included for some persons full names, addresses, and Social Security Numbers. Inline disagrees with Plaintiffs' claims and denies any wrongdoing.

**Who is a Settlement Class Member?** You are a Settlement Class Member if you are a Person residing in the United States to whom Inline sent its notice of a Data Security Incident that Inline discovered on or about March 12, 2022.

**What are the benefits?** The Settlement provides the following benefits:

- **Documented Ordinary Loss Expense Reimbursement:** Up to \$500 for documented out-of-pocket expenses and fees for bank fees, cell phone charges, credit reports, credit monitoring, or other identity theft insurance products incurred as a result of the Data Security Incident.
- **Lost Time Compensation:** Compensation for up to three (3) hours of lost time spent dealing with the Data Security Incident (\$20 per hour) for a maximum of up to \$60 per Person.
- **Documented Extraordinary Loss Reimbursement:** If you were the victim of actual documented identity theft reimbursement for documented extraordinary losses, not to exceed \$5,000 per Settlement Class Member, for proven actual monetary losses.
- **Credit Monitoring:** Credit monitoring and identity theft protection with \$1 million in insurance for two years if you did not previously enroll for credit monitoring or one year if you did previously enroll.
- **How to make a claim.** You must file a Claim Form by mail postmarked by January 5, 2024, and mailed to the Claims Administrator's address below, or online at [www.inlinedatasettlement.com](http://www.inlinedatasettlement.com) by January 5, 2024, to receive benefits from the Settlement.

**What are my other rights?**

- **Do Nothing:** If you do nothing, you remain in the Settlement. You give up your rights to sue but you will not get any money; you must submit a Claim Form to get money.
- **Exclude yourself:** You can get out of the Settlement and keep your right to sue about the claims in this Lawsuit, but you will not get any money from the Settlement. You must submit an Opt-Out Request to the Claims Administrator by December 6, 2023.
- **Object:** You can stay in the Settlement, but tell the Court why you think the Settlement should not be approved. Objections must be submitted by December 6, 2023. Detailed instructions on how to file a Claim Form, get additional credit monitoring, exclude yourself, or object are on the Settlement Website at [www.inlinedatasettlement.com](http://www.inlinedatasettlement.com). The Court will hold the Final Approval Hearing on December 13, 2023 at 9:30 a.m. CT, to consider whether the proposed Settlement is fair, reasonable, and adequate, to consider an award of combined attorneys' fees, costs, and expenses of \$250,000 and request a Service award of \$2,500 to each Settlement Class Representative, and to consider whether and if it should be approved. You may attend the hearing, but you don't have to. This is only a summary.
